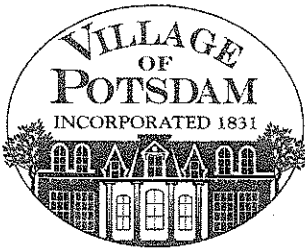

- \$2.00 added to fare per extra passenger (3rd & 4th passengers)
- \$0.70/minute added to fare per stop after 3 minutes
- 50% charge for no-shows or cancellations after taxi is dispatched **
- ** charge will be added to next Taxi Zero engagement

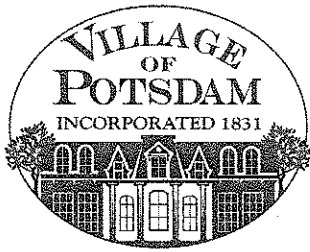
